Existing Travel Restrictions for Non-Chinese Citizens from US to China

Visa Policy

- All visas issued before Mar 28, 2020, are suspended. To get new visa the PU invitation letter from provincial government is required.
- For the work, personal and reunion residence permit holders, pre-approvals are required before travel. Even they do not need visas. Preapproval can be applied through, health.sfconsulate@gmail.com



Existing Travel Restrictions for Non-Chinese Citizens from US to China

Test policy

- All passengers need to be tested in Chinese consulates assigned test institutes. The passengers must authorize the test results to be directly transmitted to consulates when they do the test.
- The vaccinated passengers need to authorize the test institute to test N-protein antibody test from the test samples if their G-antibody are positive. (authorization form can be found in consulate website)
- If the test result are not qualified for travel, you will not be allowed to travel to China in next 6 months. (this is not published online)
- Passengers need to upload the test results to Chinese consulates to get heath certificate codes (HDC).
- Airlines need to verify the HDC before boarding the passengers.

Quarantine requirement

- 14 days in first arrival destinations
- Some cities need more days of extra quarantine time.

Existing Travel Restrictions for Chinese Citizens from US to China

Test policy

- All passengers need to be tested in Chinese consulates assigned test institutes. Both PCR and Antibody test results must be negative.
- The vaccinated passengers need to authorize the test institute to test N-protein antibody test from the test samples if their G-antibody are positive. (authorization form can be found in consulate website)
- If the test result are not qualified for travel, you will not be allowed to travel to China in next 6 months. (this is not published online)
- Passengers need to upload the test results to Chinese consulates to get a QR code.
- Airlines need to verify the QR code before boarding the passengers.

Quarantine requirement

- 14 days in first arrival destinations
- Some cities need more days of extra quarantine time.

Chinese Policy for Vaccinated Travelers

- Chinese Vaccines
 - Easier to get visa
 - No PU letter required
 - Humanitarian reunion scope increased
 - Tests and quarantine upon arrival are still needed

- Other Vaccines
 - No benefit to travel to China
 - Reason-no credible vaccine certificate

- Both round-trip flights need to stop over in Seoul for about 90 minutes for crew swap, and passengers
 do not need to disembark
- UA857 has 75% capacity limitation
- Once arrive in San Francisco, you can easily connect to 240 domestic destinations across America



All fights between China and the US are allowed to check in two pieces of luggage for free

FLYING FROM THE U.S. TO CHINA ON DELTA

IMPORTANT INFORMATION TO KNOW BEFORE DEPARTING

TRAVELER ELIGIBILITY:

International arrivals are prohibited for all **EXCEPT**:

- Chinese citizens
- Foreign nationals with a valid visa issued outside of China as of March 28, 2020
- Foreign nationals with a permanent residence permit
- Foreign nationals with a residence permit with the purpose of 'work', 'personal matters', or 'reunion'
- Diplomatic, service, courtesy, or C visas
- Those approved for economic, trade, scientific, technological, or humanitarian reasons

PRE-DEPARTURE TESTING:

Required Tests

- Negative Nucleic Acid rt-PCR <u>AND</u> IgM serum Antibody tests are both required.
 - The nucleic acid rt-PCR test result must include the sampling method as well as the testing method (either NAAT or rt-PCR).
 - IgM serum antibody test must be performed via venous blood sampling and the test results need to specify the sampling method as well as testing method.

Testing Locations

• Tests must be scheduled in or near the city of the international flight departure (Seattle or Detroit) and must be tested at a laboratory approved by the Chinese Embassy and Consulate. The approved test sites can be found here for Detroit and Seattle.*

Testing Timeline

• Both tests MUST be taken within 48 hours of the departing flight to China. This means that travelers may need to book lodging accommodations while waiting for test results.





FLYING FROM THE U.S. TO CHINA ON DELTA

IMPORTANT INFORMATION TO KNOW BEFORE DEPARTING

TESTING VERIFICATION:

Tests must be verified with the Chinese Embassy/Consulate prior to boarding the flight to China:

- Chinese citizen passengers must upload both PCR and IgM test results to the WeChat Health Code app in order to receive a green health code with the "HS" mark required for boarding.
- Foreign passengers must upload negative results of the nucleic acid and IgM anti-body tests using the <u>China Health Declaration Form</u>
 website (via computer or smartphone). Officials will examine and verify the above information and send back a QR code with the "HDC" mark for foreign passengers.
- The QR codes will need to be presented prior to boarding in Seattle and Detroit.

ARRIVAL INTO CHINA:

- All travelers who enter China are subject to additional testing or health screenings as well as a mandatory 14-day quarantine.
- All international arrivals should be prepared to complete quarantine at a government-selected facility or hotel at their own expense, with no control over the amenities, even if they maintain a residence in China.
- Cities and provinces within China may also require quarantine for domestic travelers, regardless of nationality

RETURNING TO THE U.S.

Guidance to support your travelers returning to the U.S. From international business travel.



Following orders from the Centers for Disease Control (CDC), Delta requires COVID-19 testing prior to traveling to the U.S.

All travelers over the age of two entering or transiting through the U.S. from any location outside of the U.S. must obtain a negative test result from a viral test taken within three days of departure.

To ensure your travelers are prepared for their journey, review these five steps:



Step 1

Arrive at International Airport

Eligible travelers will need to arrive at the airport with a physical or electronic copy of their negative COVID-19 test results.



Step 2

Check In

Upon arrival to the airport, travelers will check in with a Delta agent and present proof of negative COVID-19 test results.



Step 3

Proceed to the Gate

At the gate, travelers will sign CDC attestation form confirming that they have the required negative test results.*



Step 4

Board the Plane

Upon boarding, airport customer service agents will collect signed attestation forms and verify negative COVID-19 test results.



Step 5

Arrive at U.S. Airport

During reentry to the U.S., travelers may be required to show negative COVID-19 test results to CDC officials.

Approved COVID-19 tests include molecular tests, nucleic acid amplification tests (NAAT), RT-PCR tests, LAMP tests, TMA tests and antigen tests. Antibody tests are not accepted. Anyone who does not provide a negative result or meet the specific exemption criteria (such as recovery from COVID-19 within 90 days of departure, verified by a letter from a healthcare provider or public health official that states they are cleared to travel) will be denied boarding.



^{*}Travelers can also print and sign the form at home and bring it with them.





PREPARE FOR REENTRY TESTING

Before entering or transiting through the U.S., travelers must obtain negative COVID-19 test results. To prepare, travelers can use this interactive map to review testing requirements and find testing options, including both in person and at home solutions. To view this information, travelers will select the U.S. on the map, click "SEE MORE INFO" on the popup and click the dropdown arrow next to "Negative COVID-19 Test Result" for expanded details.



This map is color-coded to indicate four travel statuses: Open to visitors, open with restrictions, restricted entry and destination not available.

Click any location for information, updated daily and curated from national and local government agencies and the International Air Transport Association.



KNOW WHAT TO EXPECT

Once a location is selected, your travelers will see potential travel requirements including quarantine, testing, travel forms and paperwork. Here, they can also review local health information, local COVID-19 guidelines, links to necessary forms and applications needed prior to travel.




